



## RESOLUTION 03102025

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EAST MOUNTAIN, TEXAS ESTABLISHING A MONTHLY WATER RATE INCREASE PROVIDING FOR AN EFFECTIVE DATE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EAST MOUNTAIN, TEXAS:

**WHEREAS**, the City Council of East Mountain sees the needs to establish an increase in the water monthly rates, and

**WHEREAS**, said increase rates have been presented to the City Council and

**WHEREAS**, public notice of the monthly rate increase of \$3.00 will be duly and legally made, and a copy has been filed with the City Secretary, and

**WHEREAS**, it is the consensus of opinion by the City Council of the City of East Mountain that the monthly rates are outlined in Attachment A should be approved and adopted.

**Section I. Approval.** The City Council of the City of East Mountain, Texas hereby adopts and approves the monthly rates and charges for the Water Services as outlined in Attachment A.

**Section II. Effective date.** This ordinance shall take effect and be in force immediately upon its passage, and the caption and/or a summary shall be published once in a newspaper of general circulation.

**Section III. Findings.** The City Council finds and declares that sufficient written notice of the date, hour, place and subject of the meeting adopting this Resolution will be posted at a designated place convenient to the public for the time required by law preceding the meeting, that such place of posting was readily accessible at all times to the general public, and that all of the foregoing was done as required by law at all times during which this Resolution and the subject matter thereof has been discussed, considered and formally acted upon. The City council further ratifies approves and confirms such written notice and the posting thereof.

**Section IV.** Should and paragraph, sentence, clause, phrase or word of the Resolution be declared unconstitutional or invalid for any reason, the remainder of the Resolution shall not be affected. All Resolutions or parts of the Resolution in conflict herewith are to the extent of such conflict, hereby repealed.
