November 11, 2024

Approval of the Previous Minutes:

With the new pump station there will be enough to provide the area if they wanted.

We went on Texas Rural Water System and got a contract and will be meeting with them if everyone approves to move forward. School is ready and will bring a check and soon as approve.

Agenda Item Three: Adopt TikTok Resolution-Mayor Marc Covington


