The voter-approval rate is the highest tax rate that City of East Mountain may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that City of East Mountain is proposing to increase property taxes for the 2021 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 1, 2021 AT 9:30 AM AT City of East Mt. Conference Room 103 Municipal Dr, Gilmer, TX 75645.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, City of East Mountain is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the East Mt City Council of City of East Mountain at their offices or by attending the public hearing mentioned above.
