Roll Call:

Those Council Members present were: Mr. John Adams, Mr. Danny Medlin, Mr. Eugene Brown and Mr. Billy Morrow. Mr. Richard Lattier was absent

Open Discussion: No Open Discussion

Approval of the Previous Minutes:

Mr. John Adams made a motion to approve the minutes of the September 11, 2023 for Regular Session and Special Session Meetings and Mr. Danny Medlin seconded. The vote was unanimous.

Agenda Item One Discuss Bank Accounts-Mayor Marc Covington

The Mayor asked to combine the different bank accounts into having one account. There are only two accounts receiving interest of 1.2 % and these accounts are Money Market and Reserve. We would leave the water utility account to take care of water, police and general, just put items in different classes.

Also, mentioned taking the Water Deposit (Money Market) and Security accounts and purchasing a 12 or 18 month CD in the amount of \$100,000 which would draw the most interest. Each year would roll over the interest from the CD. Accounts nmunity Fund, Court Technology would move to another account.

Slowly move all the deposits that go into the general account to the water utility account.

Will leave the Reserve account

Mr. Eugene Brown made motion to approve and Mr. Billy Morrow second, all agreed on writing a Resolution to make these changes.

Will have Resolution to sign at next meeting.
